I understand that **all balances are paid in full 7 days prior to the date of the event** and payments are non-refundable. Changes to the total number of services can be made up to **10 days** prior to the event and schedules will be adjusted on request if not conflicting with the team's schedule. If the event does not take place as scheduled, I understand that monies collected will be held by **Beauty by Creative at Heart** and applied to the rescheduled date within six months.

Terms and Conditions (Please read and initial additional items)

- ____ 1. **Parking.** Any fees that the staff incurs while at event, such as valet, is the above parties' responsibility.
- ____ 2. **Touch ups and early start times.** If you would like one of our professionals to stay after for touch ups you must notify us before day of event. Touch ups after "ready time" are \$60 per hour and paid directly to the professional. Start times earlier than 7:00 am may require an additional fee and may require hotel room if outside of a 50-mile radius.
- ____ 3. **Travel Fees.** If travel outside of our immediate service is requested, surcharge may be required. Destination venues will incur additional fees.
- ____ 4. **Contagious Illness:** Artist may refuse service to client with skin/hair disorder including, but not limited to flu, cold, rashes, etc.
- ____ 5. **Photos.** Beauty by Creative at Heart is granted permission to use photographs for promotional use on website or social media and in artist portfolios and print unless otherwise notified in writing by client.
- ____ 6. ***Additional Services.** Additional services may be added the day of your event. However, services will be performed after all other pre-paid services have been completed.
