1. Parking. While we will utilize any reasonable means for parking, valet is sometimes the only/best choice (weather, distance from venue, etc). Any fees that the staff incurs to perform service, such as valet, will be paid by me.							
2. Touch ups and early start times. If I would like an artist(s) to stay after for touch-ups I must notify BCH before the day of event. Touch ups after "ready time" are \$6 per hour and can be paid by invoice or paid directly to the artist in cash. Start times earlier than 7:00 am require a \$50 fee per artist and may require hotel room if outside of a 50-mile radius.
